

## CLAIM FORM

This Claim Form is for use in submitting a Claim for a cash payment in the Settlement between Plaintiffs and Schnuck Markets, Inc (“Schnucks”). Further information about the litigation and additional copies of this Claim Form are available at [www.SchnucksPricingSettlement.com](http://www.SchnucksPricingSettlement.com).

### ELIGIBLE PURCHASES

A Settlement Class Member is any Missouri resident who purchased wine and spirits (“Alcohol Products”) from a Schnucks store in Missouri between December 3, 2015, and February 15, 2023 (“Class Period”).

If a valid Claim Form is submitted, Settlement Class Members will receive one of the following monetary payments from the Settlement depending on their number of eligible Alcohol Product purchases.

**Group 1:** All Settlement Class Members who submit a valid Claim that they purchased at least one (1) Alcohol Product from Schnucks during the Class Period will be entitled to a one-time payment of \$11.00. **No Proof of Purchase is necessary to receive this one-time payment.**

**Group 2:** All Settlement Class Members who submit a valid Claim, including Proof of Purchase, demonstrating they purchased between twenty-five (25) and fifty-five (55) units of Alcohol Products (wine and spirits) from Schnucks during the Class Period will be eligible to recover a one-time payment of \$25.00. **You must submit valid Proof of Purchase for all Alcohol Products claimed.**

**Group 3:** All Settlement Class Members who submit a valid Claim, including Proof of Purchase, demonstrating they purchased more than fifty-six (56) units of Alcohol Products from Schnucks during the Class Period will be eligible to recover a one-time payment of \$72.00. **You must submit valid Proof of Purchase for all Alcohol Products claimed.**

These Settlement payments, along with the cost of administering the Settlement, are subject to an overall cap of \$4,000,000.00 (Four Million Dollars and xx/100). Depending on the number of claims made, payments may need to be prorated if the total claims exceed \$4 million. The Settlement Agreement explains specifically how the aggregate cap works in different scenarios.

For payments made under Groups 2 and 3 (which require Proof of Purchase), the Claims Administrator will decide, based on the submitted Claim Form and additional required documentation, whether a Claim should be paid under the Settlement.

### HOW YOU CAN QUALIFY FOR AND RECEIVE A PAYMENT

In order to be eligible for a payment from the Settlement, you must: (1) fill out a Claim Form in its entirety; (2) sign the Verification Statement; and (3) return the Claim Form, along with any required supporting documentation, by the **CLAIM DEADLINE: September 8, 2023**, using any of the methods below:
